# Promoting Multi-Level Governance in Energy and Climate Policies

# Supporting the Creation of a Multi-Level Governance Exchange Platform

The project also supports the creation of a Multi-Level Governance Exchange Platform, enabling municipalities to strengthen their presence in national planning. A link between the national level, which is responsible for developing and implementing National Energy and Climate Plans as well as national adaptation strategies and plans, where available, and the local level, which focuses on Sustainable Energy and Climate Action Plans, is established through respective municipal associations or other suitable platforms. In addition to the role of the municipal associations as intermediaries for their members, the project strengthens their role as advocacy for the needs of local authorities at national level.
