B. Project Background

You are a young proactive team player willing to interact with solar project developers, farmers, agricultural researchers, policy makers, think tanks and financial institutions? You already have heard about the possibility of dual land use with photovoltaics and agriculture? You would be willing to spend a few days per month in a rural environment? If this is the case, you may want to become part of a dynamic team in the German development cooperation agency Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) who has entered a partnership with solar project developers to jointly develop AgriPV pilot projects in India. The overarching goal of this partnership is to prove the economic and ecological benefits of AgriPV in India. This shall be achieved by gathering evidence and data on agricultural yield as well as on the power generation from those AgriPV pilots.

C. <u>Responsibilities</u>

In close collaboration with solar project developers, agricultural researchers and the AgriPV team of GIZ India, the junior advisor will support the project team in stakeholder communication, data collection, documentation of activities, and implementation of training measures in rural India working closely together with professional consultants, researchers, and other relevant stakeholders.

D. <u>Core Scope of Tasks</u>

- Frequent field visits to pilot sites with stakeholder interaction to ensure
 - a) proper farm management.
 - b) proper solar system operation.
 - c) proper collection of all required data for research purposes.
- Assure smooth stakeholder communication and flow of information between stakeholders.
- Document the status of pilot projects and results in form of written text, photo and video.



- Identify needs for external expertise to be brought into the project and draft potential deliverables required.
- Supervise external consultants and assure agreed deliverables are being delivered in highest potential quality in a timely manner.
- Support scientific trials based on developed protocols and maintenance of records of procedures.
- Initiate and supervise training sessions for different stakeholder groups on pilot project sites
- Support other employees within the functional group.

- Masters with one year of professional experience, or bachelor's with at least four years of relevant experience is preferred.
