Background

Indonesia has made substantial progress in advancing the Sustainable Development Goals (SDGs) at both national and provincial levels. Concurrently, Indonesia also has stepped up its engagement efforts in South-South and Triangular Cooperation (SSTC) as it envisions in becoming a new emerging donor country.

However, challenges persist in coordinating efforts between national and regional levels and in scaling up SSTC initiatives. These challenges necessitate collaborative solutions to fully integrate the diverse initiatives.

As a result, there is a pressing need to enhance multi-stakeholder partnerships to accelerate progress in achieving the SDGs and implementing SSTC, embodying the core principle of Goal 17. Additionally, addressing gender issues, particularly those related to SDG 5, remains critical. Despite various initiatives, gender







perspectives have not been fully integrated into SDG implementation, thereby limiting the effectiveness of outcomes.

Strengthening partnerships across all levels is vital to mainstreaming gender equality within the SDG implementation framework, ensuring that women and girls benefit equitably from development efforts.

Against this backdrop, the project aims to foster synergy between SDG implementation in Indonesia and South-South/Triangular Cooperation. This approach represents a concrete modality for Indonesia to collaborate globally and leveraging shared expertise and resources toward sustainable development goals.

Objectives

The gender-equal and social inclusive implementation of multistakeholder partnerships for the Sustainable Development Goals and South-South and triangular cooperation has improved.

Approaches

The project supports BAPPENAS (the Ministry of National Development Planning, Republic of Indonesia) in implementing the SDGs as well as the National Coordination Team of South-South Cooperation (NCT SSC) in advancing SSTC measures and promoting collaboration in the spirit of inclusive partnership.

To achieve the objective, the project will utilize the following approaches:

- Increasing the number of gender-equal and social inclusive guidelines applied in standard processes of SDG implementation and SSTC in Indonesia.
- Conduct successful joint evaluation for three gender-equal and social inclusive Indonesian-German triangular cooperation projects.
- Conduct a successful joint evaluation for gender-equal and social inclusive implementation measures of the SDGs at the provincial level in 6 provinces.
- Increasing the number of jointly presented successful examples of gender-equal and socially inclusive SDG implementation and SSTC in international forums.
