Strengthening gender equality and participation to promote peace in Colombia

Introduction

In 2016, the Colombian Government and the former guerrilla group Revolutionary Armed Forces of Colombia – People's Army (FARC-EP) signed a peace agreement. Since then, both progress and setbacks have been observed in the implementation of the agreed measures. Eight years on, progress has been slowest with measures aimed at women, people with diverse sexual orientations and gender identities, and ethnic communities. The PazDiversa project therefore seeks to help improve the conditions for implementing the peace agreement's gender measures with regard to political participation and the Comprehensive Rural Reform, specifically for women and people with diverse sexual orientations and gender identities. In doing so, the project is making a contribution towards the principles of the German Government's feminist development and foreign policy.

Our approach

The project started implementation in February 2023 and works regionally in offices in Cúcuta, Florencia and Villavicencio, and since the end of 2024 also in Cali.

The target group of the PazDiversa project comprises population groups directly affected by the armed conflict in the regions of Caquetá, Meta, Norte de Santander and Valle del Cauca, and indirectly the entire population of these regions and the public institutions supporting them.

Mainstreaming the gender approach in the peace agreement in Colombia serves as both an example and a milestone at international level. It is also consistent with the recommendations of United Nations Resolution 1325 (2000), which calls for more direct involvement of women in security issues and peacebuilding.

However, the agreement's achievements are being overshadowed by the sluggish implementation of its 130 gender-focused measures, only 52% of which had been carried out by 2022. The biggest challenges in this context relate to the inadequate participation of the rural population and its representatives in various areas of decision-making.

The current status of implementation demonstrates the necessity of carrying out the relevant gender-specific measures while upholding the principles of feminist policy, which address (1) non-discrimination and equal opportunities, (2) participation and empowerment, and (3) transparency and accountability towards vulnerable population groups.

The institutions involved in implementation include the Vice Presidency of the Republic of Colombia, the Ministry of Equality and Equity, the Ministry of the Interior, the Ministry of Agriculture and its directorate for rural women (*Dirección de la Mujer Rural*), the National Land Agency (ANT), the Office of the High Commissioner for Peace (OACP), and the Ministry of Commerce, Industry and Tourism, particularly through its Women Entrepreneur Fund programme (iNNpulsa Colombia).







Promoting political participation and the Comprehensive Rural Reform are key elements in driving the implementation of the final Peace Agreement in Colombia forward.

The project operates in the following thematic fields:

Output 1: Promoting participation and representation in decision-making areas

The political participation of women and people with diverse sexual orientations and gender identities is strengthened within the gender-specific measures set out in the peace agreement. For example, barriers to political participation are identified and removed. In addition, the project improves the capacity of civil society stakeholders to monitor accountability for implementation of the relevant gender-focused measures and to cooperate with government actors.

Output 2: Securing the socio-economic resources needed to implement gender measures

The social and economic capacities of civil society stakeholders are developed to facilitate the implementation of gender-focused measures within the peace agreement, particularly with regard to the Comprehensive Rural Reform. This field promotes the formation of alliances with existing economic support programmes targeting women and people with diverse sexual orientations and gender identities. In addition, the technical and methodological capacities of government and civil society institutions are developed to support the creation of new initiatives for development programmes with a territorial approach, as provided for in the peace agreement.

Output 3: Changing gender biases and rights to reduce gender gaps

The project supports government institutions and civil society organisations that are working to promote implementation of the gender-focused measures, with a view to countering unequal power relations and gender-based discrimination as the peace agreement is executed. The aim is to develop a critical approach to gender roles, and to promote conflict transformation, nonviolent communication, recognition of women's movements and peacebuilding, different groups in population implementation of an intersectional approach. This field also promotes mechanisms for the protection and self-protection of women and people with diverse sexual orientations and gender identities, as well as psychosocial support for these groups in the framework of peacebuilding.

Output 4: Capacity building of state and civil society actors for the implementation of the National Action Plan on Resolution 1325: Women, Peace and Security

The technical and organisational capacities of state and civil society actors are strengthened to contribute to the intersectoral and participatory implementation of the National Action Plan of Resolution 1325 on Women, Peace and Security. For example, through accompaniment and training processes, technical and methodological advice to government entities and civil society organisations, networks and platforms, the participation of women in the prevention and resolution of conflicts is strengthened.

What we have achieved so far

- The importance of including gender equality and diversity in local and departmental policy plans has been raised. More than 300 indicators in the areas of gender, sexual diversity and territorial peace were included in Meta, Norte de Santander and Caquetá to improve monitoring of the impact of gender and diversity policies in their development plans.
- Three citizen "watchdog groups" ("veedurías") have been formalised, one per department, in Caquetá, Meta and Norte de Santander, to exercise social control and monitor the implementation of the gender measures of the Peace Agreement. Through these watchdog groups, women and LGBTIQ+ people have been able to participate in meetings to update the national public policy on citizen and electoral participation.
- At least 633 women have accessed training on the formulation of productive projects, digital skills, leadership and entrepreneurship.
- At least 1356 people have strengthened their capacities to counteract unequal power relations through creative dialogues, exchanges of experiences as well as face-to-face and virtual training on human rights, peace building, self-protection measures, prevention of violence, and alternative models of masculinity. 1054 of the participants were women, 302 men and, of these, 393 identified themselves as people with diverse sexual orientation and gender identity.
- In the departments of Caquetá, Meta and Norte de Santander, specific risks to the physical integrity of LGBTIQ+ activists have been identified. At least 489 people have been trained in protection and self-protection strategies.
