Let's do it together

In Togo, 60% of the population is under 25. The private sector therefore faces a major challenge: creating jobs offering a decent income for a growing young population. This is where GIZ comes in: we support our partners in tackling the challenges linked to supply chains, financing, digitalisation and the education system.

The greatest employment potential lies in the agricultural sector. It contributes more than 40% of gross domestic product (GDP) and accounts for 15% of export earnings. Togo exports most of its agricultural products, such as cassava, soya and pineapple, without processing them.

In order to contribute to greater profitability, GIZ is supporting small and medium-sized enterprises (SMEs) in the processing and marketing of agricultural products. At the same time, we are supporting education systems with a particular focus on disadvantaged and vulnerable groups. We are also fostering measures to promote investment, improve access to finance and digitalization. Togo's economic transformation does not depend solely on the agricultural sector. Renewable energies and the digital economy are also promising sectors for the future. In addition, the African Continental Free Trade Area (AfCFTA)

offers Togo the opportunity to open up new markets and test new business models.

AGRO-INDUSTRIAL PROCESSING

Adopting a global vision of climate change and agriculture

Togo's economy is heavily dependent on commercial and subsistence farming, with both sectors employing over 70% of the working population. At the same time, agriculture is particularly affected by climate change – especially the increase in average temperature and extreme weather events.

GIZ is helping Togo to transform its agri-food systems. We are active in several areas: rural development, reforestation, food and nutrition security and agricultural financing. Together with our partners, we provide concerted, innovative solutions. This collaboration involves working together on the design and implementation of actions and the identification of anchoring measures.

To improve agricultural production and food availability, we have developed a range of tools. These include training, support for framework conditions, assistance with equipment acquisition and access to markets.

To make agriculture a lever for economic development, such is the objective set by Togo and shared by GIZ. To this end, we have contributed through our activities to the implementation of national policy strategies such as

the National Programme for Agricultural Investment, Food Security and Nutrition, the National Development Plan and the Government Roadmap.

DECENTRALISATION

Local power, global impact

Decentralisation and good governance are crucial to the development of sectors such as health, agriculture, energy, the private sector and education.

They strengthen regional resilience and support sustainable development. GIZ support has enabled significant progress in implementing local governance structures and financial management in Togo.

GIZ works to strengthen citizen participation, inclusion and transparency. We adopt grassroots approaches and work with a range of partners to implement strategic processes. Our portfolio includes development planning and territorial marketing. But also the efficient management of state and local revenues, while fighting corruption at all levels. This



holistic and inclusive approach makes GIZ a key partner in the sustainable development of Togo.

Implementation phases of the decentralisation process in Togo

HEALTH

Better access to healthcare for all

In Togo, under the aegis of the Ministry of Health, we are committed to strengthening health systems and reducing maternal and infant mortality.

Compared with other countries in the region, Togolese women are particularly exposed to risks before, during and after childbirth. Every day, two women lose their lives during pregnancy or childbirth and its aftermath. Teenage pregnancies or experiences of violence have a negative impact not only on the well-being of the girls and women concerned, but also on their families and the community. Women's participation in social and economic life, as well as their educational and professional development opportunities, are closely linked to their health.

In collaboration with other partners, Togo is moving closer to its goal of reducing maternal mortality to 225 deaths per 100,000 births by 2030 and achieving the right to sexual and reproductive health. GIZ is actively involved in improving the quality of maternal and child healthcare services. We have supported the implementation of a national quality strategy in the health sector in Togo.

24-HOUR TESTING

To avoid long journeys, the branch of the National Institute of Hygiene in Kara has been enlarged and staff trained. This has reduced the time needed for laboratory testing from 2 to 3 days to 24 hours. This represents a major contribution to the early detection and prevention of transmissible diseases for the 2,900,000 inhabitants of the Kara, Centrale and Savanes regions.

The region was sorely lacking in staff trained in reproductive health and family planning in particular, as many experienced birth attendants had retired and others had been posted to other parts of the country. Through these training sessions on contraceptive technology, the ProSanté project is helping the region to fill this gap in the training of service providers.

RURAL ELECTRIFICATION

Relying on solar technology

Energy is the lifeblood of everything. It powers hospitals, schools and administrative units. Services and essential needs such as access to drinking water, communication and mobility depend on it. It is also a key input for the economy, enabling businesses to produce, process and trade, and so create jobs and added value.

In Togo, energy for household cooking is the biggest consumer. The national electrification rate has risen considerably in recent years, from 23% in 2010 to 60% in 2021, thanks to the implementation of the electrification strategy. However, it is estimated to be only 10% in rural areas. It is in the Savannas, in the north of the country, where the electrification rate is the lowest. The rural population therefore faces major challenges in their daily lives.

The Togolese government has set itself the target of guaranteeing universal access to electricity by 2030. GIZ is advising its partners on electrification, focusing on gender aspects and solar technologies. Together with AT2ER (in french: Agence Togolaise d'Electrification Rurale et des Energies Renouvelables), the Togolese Rural Electrification and Renewable Energy Agency, and the

Department of Energy, we are implementing the national electrification strategy. In this context, we are supporting AT2ER in promoting local solar companies, testing solar technologies for production purposes, setting up solar mini-grids, increasing the coverage of the public electricity network and advising and training potential users.
