- Research and analyse current AI datasets in Africa and develop a pilot to make these datasets accessible to African businesses.
- Organise AI policy dialogues including panel discussions and roundtable discussions at continental, regional and national conferences.
- Cooperate with a broad range of stakeholders working on AI in Africa, mainly the private sector, but also from the public sector and civil society
- Manage meetings and events of the initiative with other stakeholders and service providers (preparation, implementation, follow-up, information flow)
- Facilitate administrative and logistical procedures for activities in coordination with the GIZ administration team
- Other tasks as required
