The project addresses intersectionality, supporting the participation and empowerment of women and youth with disabilities through their umbrella organizations. The project also looks at datasets, information exchange and statistics and supports furthermore African partners in the participation at the Global Disability Summit in 2025.

- Participating in the results-based planning, monitoring and reporting of the BRIDGE-Africa project.
- Advising and supporting civil society stakeholders and networks in their capacity development, participation, advocacy and implementation processes in relation to the African Disability Protocol.
- Contributing to the Africa-wide information-sharing, coordination and cooperation towards substantive participation of persons with disabilities.
- Managing contracts with individual consultants and consulting agencies.
- Supporting the inclusion of persons with disabilities in selected continental, regional and national initiatives supported by German Development.
- Taking part in the selection process of civil-society initiatives for financial support through a transparent application process.
- Identifying innovative initiatives to be supported, promoted and documented.
- Using internal and external media platforms and social media for documentation about progress and innovations.
- Representing the BRIDGE-Africa project in GIZ-internal, national and regional events.

 University degree (at least Master or similar) in a relevant field, such as disability inclusion studies, international law, human rights, international development, social-, political- or education sciences

Professional experience

- At least 5 years professional experience in international disability-inclusive development or application of international human rights especially for persons with disabilities
- At least 3 years professional experience within or in close cooperation with multilateraland/or bilateral development partners
- Proven expertise, experience and knowledge about current trends in disability inclusion and disability rights' implementation
- Demonstrable experience in project-related cooperation, project management and /or results-based reporting
- Demonstrable experience of close cooperation with civil society organizations
