1	<p>Period of assignment: from 15 September 2024 until 31 March 2025.</p> <p>There are two budgets as per brief, are these the maximum available budgets you have available on this job with which only two events are to take place between 15 September 2024 and 31 March 2025? And do you have dates for these events?</p>	<p>Please see Chapter 1 on the Context, which specifies that a number of events are planned in the contracting timeframe. The original contracting volume can be increased by the financial volume of the option in the contract if necessary, depending on the actual number and size of the events. Further increases of the budget are not possible</p>

2	<p>Terms of reference (ToRs) for the procurement of services below the EU threshold speaks of:</p> <p>4 Concept In the tender, the tenderer is required to show how the objectives defined in Chapter 0 (Tasks to be performed) are to be achieved, Where is Chapter 0?</p>	<p>This is a mistake in the ToR. The reference should be to Chapter 2, not Chapter 0</p>
3	<p>The tender document states that ‘the complete tender must not exceed 6 pages (including CVs).’ Considering the extensive requirements outlined, can you please clarify how this is feasible?</p>	<p>According to the ToR, the limit is 6 pages excluding CVs, not including CVs.</p>
4	<p>We are unable to locate Chapter 5 in the uploaded documents. Could you please provide the format for CVs that we should use?</p>	<p>Chapter 5 contains the personnel concept. You can use any format that complied with the page limit and allows the evaluators to assess whether the criteria specified in Chapter 5 are met.</p>
5	<p>Additionally, could you send us the AUV form that we need to complete?</p>	<p>The AuV form and all other documents related to the tender can be downloaded from our website: <a href="https://www.giz.de/Call-for-Proposals/83467575">Call for Proposals 83467575 - giz.de</a></p>
