"CONSULTANCY FOR CONDUCTING A NEEDS ASSESSMENT AND CAPACITY BUILDING FOR STRENGTHENING GENDER EQUITY AND WOMEN'S PARTICIPATION IN THE TRANSPORT SECTOR"

BACKGROUND:

The project, Transformative Actions for Climate and Ecological Protection and Development (TRANSCEND), is a bilateral project of the International Climate Initiative in the Philippines, implemented by a consortium led by the Climate Change Commission (CCC) and the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH. The consortium and implementing partners include UN organisations, NGOs, and academia. Centered around a holistic approach, TRANSCEND targets integrated solutions in climate adaptation, emissions mitigation, and conservation biodiversity three distinct across landscapes within the Philippines.

The TRANSCEND project will be working on the transport sectors as one of the sectors it will be working on. The project aims to support key actors as they advance enhanced mitigation efforts in the areas of the project, adopting a gender-transformative approach through a whole-of-society strategy.

SCOPE OF WORK:

A consultancy firm will be engaged to develop a needs assessment of the current level of gender equity and women's participation in the transport sector. The consultancy firm is also expected to develop a capacity development programme based on the findings of the needs assessment. An additional knowledge product of case studies is also expected to be produced by the consultancy firm.

REQUIRED EXPERTIES:

The consultancy requires companies composed of the following: **Team leader** with a postgraduate degree in transportation studies, social development, or any related field, seven (7) years of experience in the transport sector and five (5) years of experience in doing capacity building; **a gender expert** with a postgraduate degree in gender studies, sociology, public policy, or any related field, five (5) years of experience in gender analysis or gender mainstreaming; and **a curriculum developer** with a bachelor's degree in education, social studies, or any related field and five (5) years of experience in curriculum design or training program.
