Project Name: Promoting Dialogue and Participation PDP

The German Federal Ministry for Economic Cooperation and Development (BMZ) commissioned the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH to implement the Promoting Dialogue and Participation in Iraq (PDP) project to support an environment that allows for inclusive dialogue and participation processes. The Iraqi Ministry of Planning (MoP) is acting as the political partner of the project. The PDP project aims to initiate, promote, and establish dialogue and participation formats to facilitate the inclusive development of reform proposals in Iraq. The project also supports government efforts to create conditions for an open and inclusive environment for dialogue and participation. The dialogue formats include various actors from civil society, the private sector, local and federal government, academic institutions, and think tanks, amongst others, and pay special attention to including women and youth.

Objective:

PDP has supported diverse experience in D&P processes in Iraq at local, governorate and national level. One of them was an initiative on "The Youth Voices", implemented by an Iraqi civil society organisation, in which young men and women between 18-35 years in eight governorates were trained as facilitators and supported to implement dialogues with other youth and government officials on relevant topics such as unemployment of youth, labour law implementation, and challenges for women in the labour market. Moreover, PDP has and has implemented supported the development of new training modules on dialogue and participation and has experience in implementing capacity building in D&P. This initiative can partially build upon these efforts.

The "Legal Education and Promoting Dialogue and Participation Among Youth" initiative aims to enhance the dissemination of legal culture and understanding of the rights among young people and local organizations. This effort seeks to link legal education with broader dialogue and participation mechanisms, fostering a more engaged and informed youth capable of contributing to societal development. This concept note outlines the project's objectives, target audience,

The primary aim of this initiative is to promote legal awareness and understanding of rights among youth and local organizations, while fostering dialogue and encouraging active participation. By integrating legal education with platforms for discussion, the project seeks to empower young people and enhance their role in Iraq's reform and development processes.

Following a needs assessment conducted in collaboration with relevant counterparts, the service provider (Non-Governmental Organizations) will be responsible for coordinating and delivering training to public officials from the Ministry of Youth and Sports (MOYS), the Ministry of Labor



and Social Affairs (MoLSA), human rights organizations, and youth participants. This training, developed in consultation with the Ministry of Youth (MoY), aims to improve the delivery of the legal education initiative and provide better support for youth involvement.

The initiative will include a series of workshops and seminars led by qualified local legal experts, covering a wide range of legal topics such as human rights, constitutional law, and civic duties.

Key components of the program include:

- **Interactive Workshops**: These in-depth sessions will encourage hands-on learning and discussion, focusing on the role of legal education in promoting active citizenship and civic engagement.
- **Seminar Series**: These seminars will create opportunities for youth, civil society organizations (CSOs), and public officials to engage with legal experts and academics on contemporary legal issues and best practices in legal education.

The specific topics covered in the workshops and seminars will include:

- Introduction to Legal Systems and Engagement with Government
- Understanding Human Rights: Principles and Applications
- Constitutional Law: Structure and Function
- Civic Responsibilities and Legal Obligations
- Youth and the Law: Legal Rights and Responsibilities
- The Role of Civil Society Organizations in Legal Reform
- Women Empowerment and Legal Protection
- Advocacy Skills for Effective Participation
- Legal Aspects of Social Media and Digital Rights

This comprehensive approach is designed to foster legal literacy, enhance public engagement, and contribute to the development of an informed and active citizenry in Iraq.

Logistics:

The service provider will be responsible for all logistical matters (Venue, Catering, printing material and any other related aspects).



Submission Requirements:

Interested Specialized Legal NGOs are required to submit a letter of interest along with a detailed proposal explaining their methodologies and approaches for conducting the service.

The Proposal should include:

1. Technical Proposal

- Provide a 1-page overview Knowledge of the legal framework context in Iraq and cooperation with partners, and proven track record of conducting assignments for development cooperation organizations.
- Provide a 1-page outlining the approach and methodology to be used in conducting the assessment, data collection, analysis, and modelling, explaining any models or tools to be used for the impact assessment.
- Provide a 1-page outlining the experience in the designing and delivery of training programs related to Legal Awareness.

2. Experience:

- Provide details of previous experience in conducting similar activities or projects. Highlight any expertise in benchmarking and documentation of Legal Awareness and development.
- Provide 3 reference projects in the technical field of conducting similar workshops and training courses.
- Provide references in conducting similar projects in Iraq in recent years.
- Provide details on pool of legal experts and their background.

3. Timeline

Provide a detailed timeline for this service's completion, the expected starting date is 10th February 2025 until the 10th of Sep. 2025.

Additional Requirements:

For Non-Governmental Organizations (NGOs):

To be considered eligible and formally accepted, please provide the following requirements.



- 1. Average annual turnover for the last three financial years (last-but-four financial year can be included in case of tenders held within six months of end of last financial year).
- 2. Average number of employees and managers for the past three calendar years
- 3. Introduction of the NGO (NGO profile including organization chart)
- 4. Scanned copy of the license and registration for working in Iraq.
- 5. Valid local bank account under NGO name.
- 6. Affidavit confirming no blacklisting, litigation, or involvement in the last two years.
- 7. Three Similar contracts implemented by the NGO, including the contract values.
- 8. Letter to GIZ expressing interest in participating in the tender.
- 9. Full names of the owner and representatives, with their signature samples.
- 10. Stamp samples.

Eligibility:

The information provided in the sections regarding the Technical Proposal, Experience, Timeline, and Formal Documents will undergo an evaluation process. The assessment of this information will play a crucial role in determining your eligibility for participation.

Submission Guidelines:

Interested NGOs must submit the aforementioned documents and complete contact details before the specified date via email to procurement.iraq@giz.de . Non-compliance may result in the submission being deemed non-responsive. The email subject line should be "Call Expression of Interest (EOI) for a tender in Legal Awareness and Promoting Dialogue and Participation among Youth

The deadline for submission is set for 01.02.2025 at 17:00. Late submissions, from any NGO, will unfortunately lead to exclusion from consideration. This expression of interest is a market search for qualified NGOs. GIZ keeps the right to the appropriate selection of the best-qualified NGOs.
