

## Call of Express of Interest (EOI) for a tender for Mosul Agripreneur Skill Enhancement and Incubation Programme

PROJECT NAME: Employment Prospects for Socio-economic Integration of Refugees, IDPs, and Host Communities (EPSI)

GIZ in Iraq is looking for a service provider to design and implement an intensive entrepreneurial and business incubation programme for a group,35 persons, of the potential young entrepreneurs among vulnerable communities, including Internally Displaced Persons (IDPs), Refugees, host communities, women (50%), and persons with disabilities (10%) at Mosul, Ninawa. The programme aims to enhance the technical skills of the participants, enabling them to establish new enterprises in the agriculture sector and its value chain in Mosul. The programme will be blended, in class and hands-on experience, to ensure the contribution to the ecological transition and climate change adaptation by learning the sustainable and ecofriendly practices in the sector. The duration of the training days should be not less than 30 days and no more than 45 days. Finally, the participants should be able to develop their business model and plan. Successful participants who develop a viable and sustainable business model will have the chance to receive seed funding and/or pitch their ideas to potential investors to start or accelerate their enterprises.

## **Objective**

To empower 35 potential entrepreneurs in Mosul, among the vulnerable communities, by enhancing their agricultural technical skills, business management, entrepreneurial skills, and innovation capabilities to start or sustain their enterprises within the agricultural sector.

- A scanned copy of the license and registration that the company is able to work in Mosul, Iraq.
- Bank data with all details from a local bank (Bank Name, Account Holder, IBAN).
- Provide an Affidavit that the firm has been neither blacklisted by any Government, semigovernmental institute, or private institute nor involved in any litigation in the current or during the last two (2) years or a (self-disclosure).
- Annual turnover of the last three financial years.
- Structure of the company and number of employees.
- Reference of similar implemented projects, especially in agriculture sector, including their values in the last three years.
- Provide a letter directed to GIZ exploring:
  - Your company is interested and will participate in the tender.
  - Full names of owner and representatives, with their signatures' samples.
  - The stamp samples.
- experience in the business incubation in agriculture sector in Nineveh,
- knowledge about technical capacity building programs, and



Knowledge of the entrepreneurship ecosystem in Iraq.
